It highlights the differences between the Litigation Process, including settlement talks, and a Mediation process where clients are legally represented at the mediation. We will look at current and proposed Mediation Legislation, the Draft Mediation Bill 2010 and the growth of Mediation here and in other jurisdictions.

The training course gives participants a basic understanding of how Mediation can be used to resolve disputes involving litigation, interpersonal breakdown in the workplace, Family Disputes, Divorce & Separation, and also General Commercial / Contractual cases.
